

HOODOO 500 COVID-19 SUPPLEMENTAL WAIVER

I acknowledge that a sporting event, including all categories and activities related to participation in any capacity in the Hoodoo 500 races (hereinafter HOODOO) may occasionally put a participant close to another human. Being closer than six feet, or possibly even a farther distance than six feet, could cause me or others to get sick from an unknown virus, including COVID-19, or another infectious agent. These risks are not only inherent to athletes but are also present for volunteers and crew members. I hereby agree to assume all of the risks of participating and/or volunteering in the HOODOO.

- ⇒ "I certify that if I have tested positive for COVID-19 within 21 days of participation, or I have cold or flu-like symptoms, I will not attend this event." INITIAL: _____
- ⇒ "I understand that HOODOO will endeavor to follow all health guidelines set forth by the CDC, State, County, and local permittees for the event. Any guideline changes or updates may result in changes to the event production at any time." INITIAL: _____
- ⇒ "I acknowledge that this HOODOO 500 COVID-19 SUPPLEMENTAL WAIVER (hereinafter COVID WAIVER) will be used by the event holders, sponsors, and organizers of the HOODOO and govern my actions and responsibilities at HOODOO. In consideration of my registration, and permitting me to participate in the HOODOO, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me, including attorney's fees, litigation costs, and my traveling to and from the HOODOO and including participation in the HOODOO in any way, THE FOLLOWING ENTITIES OR PERSONS: Planet Ultra, Inc., its directors, officers, employees, volunteers, representatives and agents, the event holders, event directors, event sponsors, event staff, vendors, event volunteers, property owners (hereinafter collectively PLANET ULTRA); Specifically I hold harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in the HOODOO whether caused by the negligence or gross negligence of releases or otherwise." INITIAL: _____
- ⇒ "I acknowledge that an inherent risk of exposure to COVID-19 exists in any public place where people are present." INITIAL: _____
- ⇒ "I acknowledge that an inherent risk of exposure to COVID-19 exists in any group athletic events, including HOODOO." INITIAL: _____
- ⇒ "I voluntarily assume all risks related to exposure to COVID-19 that may arise from my participation in HOODOO." INITIAL: _____
- ⇒ "I acknowledge and accept that I may not hold PLANET ULTRA liable for any exposure to COVID19 or subsequent infection with any virus or infection that may arise from my participation in HOODOO." INITIAL: _____
- ⇒ "I acknowledge and accept that the State of Utah has implemented a contact tracing plan to stop the spread of COVID-19, and may demand that PLANET ULTRA turn over any participant lists to the State for that purpose. By signing this waiver, I permit PLANET ULTRA to provide my contact information to the State of Utah for the purpose of COVID-19 contact tracing, if the State so requests." INITIAL: _____

This COVID WAIVER shall be construed broadly to provide a release and waiver to the maximum permissible under applicable law. This COVID WAIVER is in addition to any other waiver and release of liability I have signed related to the HOODOO and does not replace the terms of those agreements but rather augments and extends them. I further agree to abide by all the rules and regulations as set forth by HOODOO and the PLANET ULTRA. I hereby certify that I have read this document and understand its content.
